## About the Training to Transformative Gender Research Program

The Training to Transformative Gender Research Program has created a mentoring relationship between distinguished professors and researchers and junior faculty and Ph.D. students in universities in the Arab region in order that their research might be a catalyst for transofmative developments in their ommunities.

Participants attend a series of four seminars over the course of two years. During this time, with the guidance of their mentors, they gather and analyze their data, hone their writing and research, and produce a finished piece for publication. The final seminar, the culmination of partipants' efforts, will be a workshop for participants to finalize their projects for publication.

#### About Dr. Suad Joseph

Dr. Suad Joseph is the founder and lead trainer of the Training to Engaged Research Group and is Distinguished Professor of Anthropology and Gender, Sexuality, & Women's Studies at the University of California Davis (USA). She is General Editor of the Encyclopedia of Women and Islamic Cultures (Brill, 2003-2007) and EWIC Online (2009 – present) and has edited/co-edited 8 books, and authored more than 100 articles. She has founded or co-founded a number of scholarly organizations and groups, and currently leads a Consortium of 5 universities in Egypt, Lebanon, and Palestine, with UC Davis. She is the founding Director of the Middle East/South Asia Studies Program at University of California, Davis, and has been recognized with numerous awards for her teaching and service activities at that university. Dr. Joseph has received grants from a number of international organizations, including the Ford Foundation, the Henry Luce Foundation, the International Development Research Center, the National Science Foundation, the Open Society Institute among others. She completed her PhD in Anthropology from Columbia University (USA) and has taught proposal writing and research design for over 30 years. #### **OVERVIEW**

In advance of the seminar, participants will be invited to read key documents on Dr. Suad Joseph's website on proposal writing: <u>http://sjoseph.ucdavis.edu</u>. The key documents are available in Arabic and English. The workshop includes intensive lectures that present all the components of a research proposal in condensed form on the first day of the seminar (Dr. Suad Joseph). The second day will have lectures on feminist approaches to gathering data on gender violence and on human subjects protocols (Drs. Zeina Zaatari, Lena Meari, Nadine Naber and Suad Joseph). Participants will work in writing groups on assignments. On the last day, each participant is required to give a presentation on their data gathering approaches to their research problem to the whole seminar. Following the seminar, the trainers will inform the participants whether their applications for funding were successful and how much funding they will receive. They will be required to commit to the methods and budget itemized in their successful proposal. During the following six months, participants will work with assigned mentors to gather data on their topic of research related to gender violence in the Arab region. The third seminar on data analysis will be in February 2019 and the final seminar, focusing on writing/publishing, will be in July 2019. In the two years, the researchers will complete a research proposal, the data gathering for that proposal, data analysis of the materials collected, and writing their report/article.
